PARKING

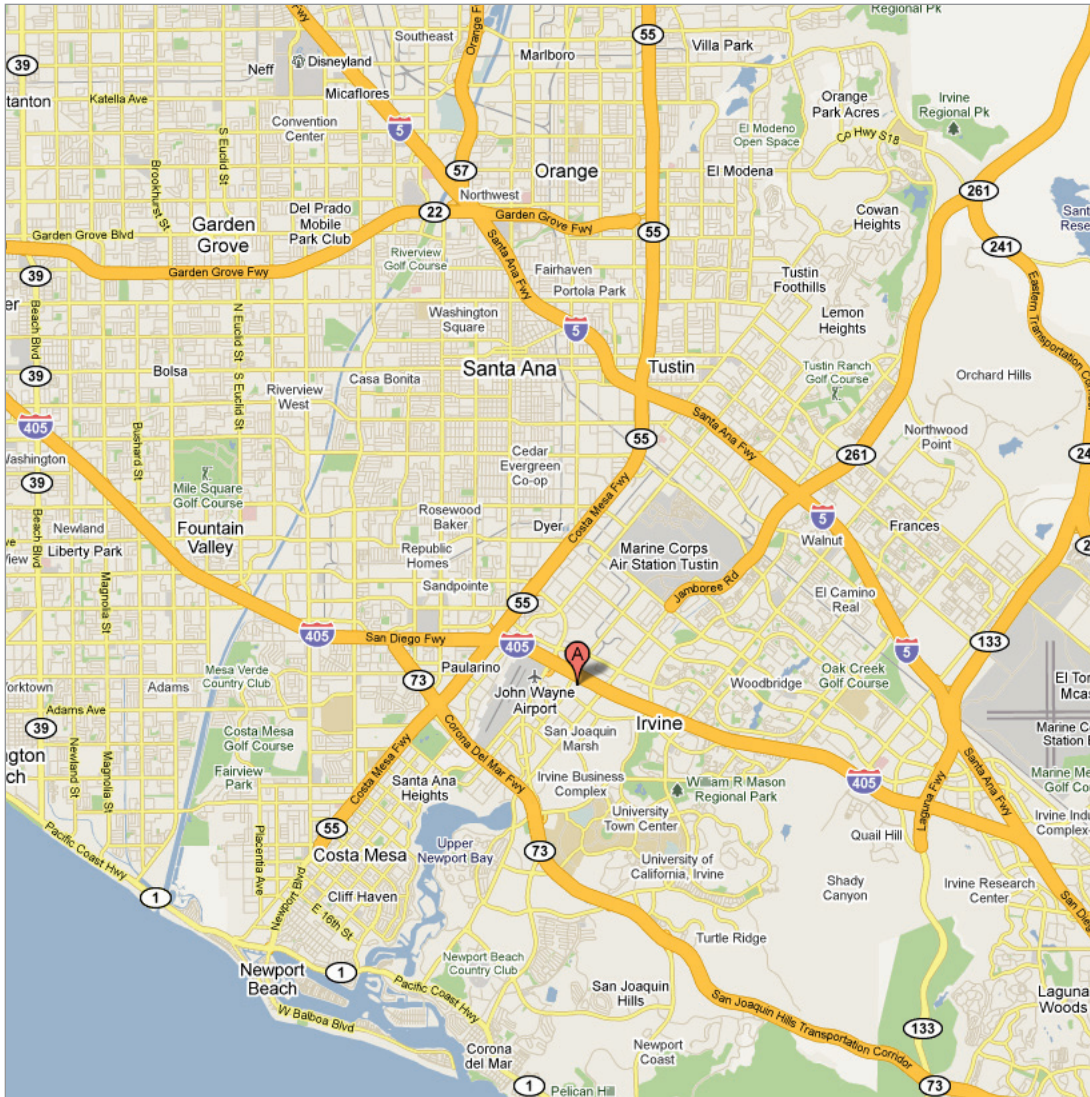
