Upcoming IRS 501(c)(3) Workshops

The Internal Revenue Service will offer one-day workshops for small and mid-sized 501(c)(3) exempt organizations in 2007 and 2008. The workshops are designed for administrators, volunteers, and tax practitioners who are responsible for tax compliance. Registration is on a first-come, first-served basis (limited to 200 attendees per workshop), and the non-refundable cost is \$45 (including a text and other IRS forms and publications).

Workshops will be held in 2008 in Austin on May 6, 7, and 8. Additional dates and locations are available in Salt Lake City, UT, Columbia, SC, Sacramento, CA, Arlington, VA, and Columbus, OH.

The workshops focus on how 501(c)(3) organizations can protect their tax-exempt status and comply with all their federal tax requirements. Each workshop should also cover unrelated business taxable income ("UBTI"), gaming, employment issues, the new Form 990, the new "e-Postcard" filing requirements, various required disclosures, and the Pension Protection Act of 2006.
