Oil and Gas ESG Tracker

- HB and EnerCom are tracking the publicly disclosed ESG policies of 30 US-listed middle market onshore oil and gas producers with a market cap greater than \$100 million.
- The Tracker reports if and how oil and gas companies are responding to growing pressure to support and communicate ESG policies and report their progress implementing those policies.
 - Companies are disclosing ESG policies in a variety of places, including on company websites, corporate social responsibility reports, in proxy statements and other SEC filings.
 - The scope and extent of the disclosures, if any, varies widely among producers.

American Jobs Plan

- Biden Administration Infrastructure Bill
 - Issued March 31, 2021
 - "Overhaul and Upgrade" the Nation's Infrastructure
 - "Transformational Effort" to create the "Most, Resilient, Innovative Economy in the World"
 - "The Largest American Jobs Investment since World War II"
 - Approximately \$2 Trillion
 - 8 Year Spending Plan
 - If passed alongside the Made in America corporate tax plan, it will be fully paid for within the next 15 years

American Jobs Plan

- Purpose
 - Create Millions of Jobs
 - Environmental Justice
 - Hasten shift to "Cleaner Energy Sources"
- Revenue Generation Accompanying Made in America Tax Plan
 - Corporate Tax Rate Increase
 - 21% to 28%
 - "Minimum Tax" on Global Income of Multinational Corporations
 - "Elimination of Tax Preference for Fossil Fuel Producers"

American Jobs Plan

- \$180 Billion for Research and Development
- \$115 Billion for Roads and Bridges
- \$85 Billion for Public Transit
- \$80 Billion for Rail (Freight and Passenger)
- \$42 Billion for Ports and Airports
- \$100 Billion for Broadband
- \$111 Billion for Water Infrastructure
- \$16 Billion for "Transition of Fossil Fuel Workers to New Work"
- \$10 Billion for "Civilian Climate Change Corps"

Climate, Climate Everywhere...

- Treasury
 - First "Climate Counselor" John Morton
 - Mobilizing financial resources for climate-friendly investment and expedited transition of high-emitting sectors
 - Using economic and tax policies to support climate-resilient infrastructure and transition to net-zero decarbonized economy
 - Centrally featuring environmental justice in programs, policies and activities
- DOI
 - Climate Task Force
 - NEPA, climate change, and Tribal and environmental justice factors
 - Trump-era Orders revoked

Corporations Going Net-Zero

- Corporations in many different sectors are announcing plans to achieve netzero.
- Most aim for net-zero by 2050

International Climate Change Policies Affecting Transportation

- EU: Year of Rail
- Bail-Out Packages:
 - AirFrance-KLM
 - Deutsche Lufthansa AG
- Bill in French National Assembly
 - Air Travel forbidden when train alternative is less than 2.5hrs

Climate and the Proposed Preliminary Budget

- EPA proposed \$11.1 billion, up 21.3% over FY2021
 - \$936 million to new EJ initiative at EPA
 - \$100 million to new community air quality monitoring and notification program
 - \$550 million to remediation of abandoned oil and gas wells (triple current funding)
- Department of Energy Proposed \$46 billion, up 10.2%
 - \$1.9 billion to launch clean energy and workforce initiative
- Other proposed spending:
 - \$600 million for electric vehicles and charging infrastructure across agencies
 - \$1.7 billion in energy saving retrofits to homes, schools and federal buildings
 - \$1.6 billion across agencies for a broad range of research on understanding the changing climate and adaptation and resilience measures
 - \$1.2 billion to the Green Climate Fund to help developing countries reduce emissions and adapt to climate change and another \$1.3 billion for other climate programs including at USAID
 - \$6.9 billion to NOAA to include expanding climate observation and forecasting work

- Focus on criminal actions
- E15 and UST proposed changes
