Haynes Boone and 16 of the firm's lawyers are ranked in the *Benchmark Litigation U.S. 2023* list of the nation's leading litigation firms and lawyers, published by Euromoney Institutional Investor PLC.

The firm is ranked in Tier 1 nationally in Insurance as one of the Top 8 insurance litigation firms in the country. In Texas, Haynes Boone was also "highly recommended," the top tier, in Labor and Employment and "recommended" in Dispute Resolution.
