In another instance David secured dismissal of a lawsuit seeking \$750 million in damages and other relief against Marvel instigated by former business associates of Stan Lee claiming that Mr. Lee had conveyed to their company rights to the Spider-Man, Ironman, and Incredible Hulk characters Mr. Lee co-created during his employment by Marvel.

The diversity and depth of David's litigation experience is reflected in his representation of institutional, private equity and other real estate investors and developers in restructuring and inter-creditor disputes arising from investments in real property, mortgage loans and mezzanine debt as well as clients involved in a wide range of high value contractual disputes and class actions.
